

CDL Required Documents

Please bring the following documents with you when applying for a CDL license.

- 1. Valid DOT Medical Card. 52 restriction requires proof of current employment.
 - PLEASE NOTE: Employees of a government entity must have a current, valid D.O.T.
 medical card if making application for a CDL with a HazMat (H), Passenger (P) or
 School Bus (S) endorsement.
- 2. Proof of your Social Security Number.
- 3. Proof of Identity: Tennessee driver's license, or a valid driver license or CDL from another state.
- 4. Proof of Domicile in Tennessee.
 - Applicants for a CDL or permit will be required to present two proofs of domicile
- 5. Proof of U.S. Citizenship or Lawful Permanent Resident Status.

What proof of U.S. citizenship documents are authorized?

- Valid, unexpired U.S. Passport.
- Certified birth certificate filed with a State Office of Vital Statistics or equivalent agency in the individual's State of birth, Puerto Rico, the Virgin Islands, Guam, American Samoa or the Commonwealth of the Northern Mariana Islands.
- Consular Report of Birth Abroad (CRBA) issued by the U.S. Department of State. (DS-1350 or FS-545).
- Certificate of Naturalization issued by the U.S. Department of Homeland Security (DHS). (N550, N570 or N578).
- Certificate of Citizenship issued by DHS. (N560 or N561).

What Proof of Lawful Permanent Resident document is authorized?

• Valid, unexpired Permanent Resident Card, issued by USCIS or INS. Must be a ten (10) year Permanent Resident Alien Card.

What do I need to bring for domicile?

Two (2) documents are required from the list below. All documents must include a Tennessee residential address—the SAME residential address must be on each document presented. No photocopies or computer generated printouts with URL's accepted! Acceptable Documents:

- 1. Current utility bill, dated within the last four (4) months, including landline telephone, electric, water, gas, cable, etc. (Wireless telephone bills cannot be accepted).
- 2. Current vehicle registration (personal vehicle not company vehicle) dated within the last 12 months.
- 3. TN vehicle title showing TN address (but can't use a title and vehicle registration as both proofs).
- 4. Mortgage papers such as the property deed or mortgage payment coupon/book.
- 5. Copy of Lease Agreement or Contract with notarized signatures OR accompanied by signed realty agency letterhead confirming lease validity.
- 6. Voter registration card NOT the application for voter registration.
- 7. Military LES papers listing Tennessee as home of record.
- 8. Current filed tax return W2's and 1099's accepted if the address is printed on the document.

Legal Name Change

Certified documents are required to verify any/all legal name changes, marriage certificate(s), divorce decrees, court documents.

S Endorsement

Requires Form 2-C. New/returning residents must provide current driving record dated within the last thirty (30) days.

H Endorsement

Requires all documents listed.
